Minutes

Mike motion to approve, seconded Joe V - APPROVED

Financials (Anne)

Expenses down, income up. \$27,872 better than budget overall

- SCRIP profit is \$3400 above budget
- o Personnel \$5000 less than budget
- Shared expenses \$12,500 under budget
- Mass attendance numbers are up from recent history
- YTD Envelope/Loose offertory is up as well (\$1061 ahead of budget)
- Strong staff generating enthusiasm

Old Business

- Cemetery- an offer is being extended to a candidate for sexton, working on a bookkeeper
- Office would be at St. Patrick's
- Visitor envelopes in pews
- Neighbor with the drainage issues In Process
- Funeral and Estate Planning workshop and that is coming up on April 27th
- Charge Card System- Square Terminal for \$299 will be purchased for future use

New Business

- School investment for 2024-25 (subsidy to SMCS)
 - Building and maintenance, utilities, spreadsheet model to level playing field for smaller parishes
 - In 2023 it was adjusted to 35% of envelope giving, SMM does not want to pay
 - St. Mary's took a large increase to subsidy in 2023
 - St Patrick has higher maintenance and overhead expense without parish size to sustain
 - Top line proposal shows \$6300 increase to Saint Gabriel, but percentage is similar for all

- Motion to approve Comparisons for School Investments (Subsidy) as presented by Lynn, seconded by Dave (attached) – APPROVED
- \$200,000 donation from a deceased parishioner, potentially more. Currently in Money-Market, may be moved to contingency fund (60/40 stock to bond) or CD
- Joe V. made a motion to open \$100,000 13-month CD at Fox Communities for 5% and a \$100,000 7-month CD at 5.25%. – APPROVED
- Lynn working on grants with Department of Justice for digital mapping for 3 buildings to provide EMS personnel access
- Lynn working on other grant items such as fencing, doors, locks, etc.
- Remember & Rejoice Event is Saturday, April 20th to thank organ donors

B&G Update (Mike)

- Lappen Lock proposal. We have **medico** locks **with keys that we can no longer copy.** Related to Lynn's grant discussion.
- JC Security came in at a lower bid for a similar project in improving locks. **We have worked with this company in the past**.
- Fox Valley Sealcoat sealed the parking lots approximately 3 years ago. Assessment to redo this summer is about \$7,500. Mike recommends we move ahead with this.
- Roof replacement proposal from Security Luebke was looked at with Mike and others.
 20-year warranty. Original estimate was \$186,000, but reduced to \$175,000. Fiber membrane roof. Boldt said this is the top-rated roof you can get. Slotted in June, we have \$172,000 already set aside. 3-week turn time. Gym, office, and early learning roofs to be replaced.
- Lawn mowing price increase up \$300 per year. 18 mowings at \$30 an hour. Finance
 Council approved
- The Finance Council approved a \$500 donation for the snow removal company since he was hurting financially with lack of snow this winter.

Vision Project

- Questions on paint color behind statues and crucifix. Committee will re-evaluate the
 entire look in front of the church after the walls of Sanctuary are completed as this
 may change the look.
- Sanctuary side walls should be complete in Fall (attach vision numbers report)
