Why do we exist? (MISSION)

Bring people to Christ and ultimately Heaven/God, Eucharist/Sacraments, Provide Spiritual food, Mass-Heave on earth (Church), Share/Spread the Word, Community

How do we exist? (Specific of the Mission)
